## Foreword

This plan sets out the arrangements made by the Regional District of North Okanagan (RDNO) to ensure an informed and coordinated evacuation to an emergency event at or near Silver Star Mountain, which will protect life as the priority.

The purpose of the document is to enhance and provide guidance to the coordination of an evacuation response. It is designed to be used by the RDNO in conjunction with existing emergency plans, the Regional Evacuation Framework, area response maps and general emergency response procedures for the RDNO.


The Operational Guide is a controlled PROTECTED document and is CONFIDENTIAL. The contents should not be altered except when an update is issued via the designated Emergency Program Coordinator. The plan also holds personal telephone numbers for various organizations and stakeholders. This information must not be made available to anyone other than vetted EOC staff involved with managing an incident.

EOC staff will need to use their professional judgement and will require a level of competence to undertake the key incident management roles.

This guide does not replace the need for staff training and shall not operate as a stand-alone plan for evacuations within the RDNO but shall be read in conjunction with the existing emergency response plans and procedures that guide the activation an Emergency Operations Centre (EOC) and supporting roles.

## 1 Silver Star Summary

Silver Star BC is a resort community located 22 kilometers northeast of Vernon, in Electoral Area 'C' of the Regional District of North Okanagan. Silver Star is situated on the edge of the Okanagan Highlands typified by rolling summits. The elevation at the top of Silver Star Mountain is 1890 metres above sea level. The base Village is situated at 1600 metres asl. The area lies within the 'Interior Douglas Fir' and the 'Sub-alpine Engleman Spruce and Douglas Fir' Biogeoclimatic Zones. Skiing and other winter activities are the major focus of the community with special summer entertainment programs and summer recreation sports completing the year round resort calendar.

#### SITUATION ASSESSMENT: Evacuation Alert

- Trigger Point for Evacuation Alert determined by EOC Director
- "Critical Stakeholder Notification" contacts (below) to be advised of Alert when declared
- Place individual calls request their email for conference call / webinar invites
- Establish Conference Call / Webinar schedule
- Messaging for residents at Alert Stage:
- Be prepared to leave immediately if given an Order
- Residents encouraged to pre-plan where to re-locate if given an Order
- Under an Evacuation Alert, livestock owners need to be notified that they should be addressing their livestock issue and not waiting for an Evacuation Order.
- If you want to relocate trailers relocate during evacuation alert do not wait until order.
- Park Vehicles to allow easy evacuation.
- Upon an Order, only single vehicles will be permitted on the evacuation route, not trailered boats and RVs etc.

## 2 Evacuation Planning

Evacuation Trigger Points for interface wildfire can be determined by reviewing the hazard data available for Silver Star, its proximity to structures and the fuel to map a 2km and 5 km buffer around structures. It will be important to consider the implications to Silver Star Road and depending on where the wildfire originated, a larger buffer may be needed to maintain egress. Shelter-in-place or egress via an FSR are potential options but will take additional time to initiate.

The assumed lane capacity for a single lane is calculated at 500 vehicles per hour. Allowance is given for official and mass transportation vehicles. Vehicle speed assumed 40km/h, with vehicles in good working order and residents "ready to go" and in vehicles. FSR lane capacity is estimated at 300 vehicles per hour with an assumed vehicle speed of 30km/h.						

Evacuation clearance times are estimated based on the maximum number of people that may be in the area at one time. This number will vary depending on the area being evacuated, the time of year, time of day, etc.




## 3 Evacuation Considerations

A hazard event in the Silver Star area has the potential to be complex and challenging given its remote location and limited options for access/egress. Proper considerations must be given to determining the best course of action (evacuation/shelter-in-place) as well as the appointment of supports such as traffic control, signage and assembly points (see Regional Evacuation Planning Framework).

While recommendations for placement of these supports have been made, adhoc planning may be required and adjustments made to meet the needs of the incident. KMZ files accompany this document and can be used to facilitate future adhoc evacuation planning and situational awareness.

## 3.2 Forest Service Road (FSR) Access

#### 3.2.1 Deafies FSR

Deafies FSR is owned by FLNRORD and numbered 0962 Section 08.

The first 6km from Silver Star Village are maintained by the resort, the remainder is maintained by the users under a Forest Service Road Maintenance Agreement.

As of May 23, 2022 the following companies hold Road Use Permits (RUPs)

- Primary Monashee Community Forest (0.0-2.0km)
- Primary BC Hydro (2.0-5.4km)
- Secondary Woodlot WL 1908 (554210 B.C. Ltd) (0.0-1.2km)
- Tertiary BC Hydro (o.o-2.okm)

Notes:

- Typically for estimating grading a competent grader can grade, shape and crown 4km of FSR in 10hrs.
- Current funding and spending plan policy are not congruent to maintain the road to a high standard

- Legally, to erect any signage along an FSR, authorization by the Okanagan Shuswap District Manager must be obtained prior to installation.
- The legislation does provide MoF to issue a maintenance agreement to another agency authorizing them to do maintenance on the FSR however, the funding responsibility lies with the agreement holder for any maintenance work.
- When issuing a Road Maintenance Agreement MoF do not have the authority in their engineering policy to support access for emergency egress.

#### Discussion

The stakeholder engagement event focused primarily on reviewing hazards and alternative route options as well as the potential for shelter-in-place versus evacuation. The members of the Silver Star Property Owner's Association (SSPOA) and representatives from Silver Star Mountain Resort, voiced concern over the option to shelter-in-place based primarily on the concern that the parking lots would

be full during peak season. While valid points were brought forward, it was evident that there is some misunderstanding of what a shelter-in-place would look like as well as the circumstances surrounding it. Additional planning and discussions surrounding how a shelter-in-place would be executed are advised as there is potential that this strategy may be the best option if the main route is unpassable.

The second dominating conversation during the workshop was surrounding the use of Deafies FSR, or any FSR for that matter, as an alternative evacuation route. While it does sound as though Deafies FSR could accommodate most vehicles, in order to formally designate it as a secondary evacuation route there would need to be a system in place to ensure its regular maintenance. Several options were discussed during the stakeholder engagement session but as outlined in section 3.9 of this document, someone would have to take ownership of maintaining the road and would need to apply for a Road Use Permit or a maintenance agreement with the FLNRORD. Additionally, authorization to install emergency signage must be authorized by the FLNRORD district manager.

While Deafies FSR is the most feasible option for a secondary egress route, the cost, resources, and liability that the RDNO would acquire should be carefully considered prior to taking the steps to designate this FSR as a secondary evacuation route. It is worth considering that preventative measures such as Fire Smart and fuel mitigation can significantly improve the safety of this community and efforts may be better directed to maintaining existing fuel breaks, treating the forest stand along Silver Star Road and running an aggressive public education campaign surrounding Fire Smart, emergency management and the responsibility of individuals to understand their risk and prepare accordingly.

### **Recommendations**

#### Recommendation #1: Personal Preparedness Campaign

It was evident from the discussions at the stakeholder workshop that, while some good work has been done surrounding Fire Smart, residents have limited knowledge of how to prepare themselves for an emergency. It is important to educate and empower residents to learn about the hazards in their community and prepare accordingly. The RDNO is currently updating their emergency management webpage; along with that, a strategy for directing residents to review the information and take the necessary steps to prepare themselves and their household is imperative. Additionally, educating residents on the phases of an evacuation and the corresponding procedures will help ensure compliance and an efficient evacuation if necessary.

#### Recommendation #2: Shelter-in-place Planning

Discussions that took place with stakeholders uncovered a lack of understanding around why a shelter-in-place may be chosen over an evacuation and what that would look like. It would be helpful to complete additional shelter-in-place planning in partnership with the resort to ensure that there is a contingency option if needed and appropriate.

#### Recommendation #3: Feasibility Study for use of FSR's

While the discussion surrounding the use of Deafies FSR as a secondary route has been discussed several times, there has yet to be an entity that is willing to take on the responsibility of maintaining the road for the purpose of an evacuation route. The workshop afforded the group the opportunity to discuss the matter with all parties present which provided a shared understanding of the steps required to designate the road as an evacuation route. Although the consensus remains that Deafies FSR appears to be the most viable option for a secondary egress from the mountain, it will remain with the RDNO to determine whether they are willing to take the necessary steps to designate it as such.

#### Recommendation #4: Fuel Mitigation and Community Wildfire Resilience Planning

Continue to update Community Wildfire Resilience Planning and bring in Wildfire Specialists and Registered Professional Foresters (RPFs) to develop recommendations and prescriptions for mitigating existing wildfire risk to the community as well as Silver Star Road.
